**EMERGENCY SERVICES: THE EMERGENCY SERVICES PROGRAM IS DESIGNED TO BE THE FIRST STEP IN THE CONTINUUM OF ASSISTANCE TO PREVENT HOMELESSNESS AND ENABLE HOMELESS YOUTH AS THEY MOVE TOWARDS INDEPENDENCE AND STABLE HOUSING. EMERGENCY SERVICES PROVIDED BY LNFY INCLUDE STREET OUTREACH, DAY SHELTER, EMERGENCY BEDS AND RAPID REHOUSING.**

**EMERGENCY HOUSING: LOST-N-FOUND YOUTH'S PROVIDES THE EMERGENCY HOUSING PROGRAM TO MEET THE IMMEDIATE HOUSING NEEDS OF HOMELESS YOUTHS, UP TO 90 DAYS, OR UNTIL OUR CASE MANAGERS LOCATE A STABLE ALTERNATIVE LIVING ARRANGEMENT FOR THE CLIENT. DURING THE CLIENT'S TIME AT LOST-N-FOUND EMERGENCY HOUSE, YOUTH HAVE 3 SQUARE MEALS PER DAY, CLOTHING, AND THE RANGE OF SERVICES PROVIDED THROUGH THE LNFY YOUTH CENTER. PRESENTLY LOST-N-FOUND**

**YOUTH HOUSE: THE YOUTH HOUSE IS A 6-BED FACILITY LOCATED IN ATLANTA'S HISTORIC WESTEND WHICH HOUSES YOUTH FOR UP TO 6 MONTHS WHILE THEY BUILD THEIR INDIVIDUAL CAPACITY FOR INDEPENDENCE, SELF SUFFICIENCY AND PERMANENT HOUSING. WHILE ENROLLED IN THE YOUTH HOUSE YOUTH ARE REQUIRED TO SECURE AND MAINTAIN FULL TIME EMPLOYMENT, SAVE 60% OF THEIR EARNING, ABSTAIN FROM DRUGS AND ALCOHOL, MEET TWICE PER WEEK WITH CASE MANAGERS, AND COMPLY WITH ALL CURFEWS AND RULES OF THE HOUSE. IN ADDITION TO CORPORATE OFFICES THE THRIFT STORE IS A DONATION CENTER AND SERVES AS THE FIRST POINT OF CONTACT FOR MANY VOLUNTEERS, DONORS AND CLIENTS.
