EMERGENCY SERVICES PROVIDED BY LNFY INCLUDE STREET OUTREACH, DAY SHELTER, EMERGENCY BEDS AND RAPID REHOUSING.

EMERGENCY HOUSING: LOST-N-FOUND YOUTH PROVIDES THE EMERGENCY HOUSING PROGRAM TO MEET THE IMMEDIATE HOUSING NEEDS OF HOMELESS YOUTHS, UP TO 90 DAYS, OR UNTIL OUR CASE MANAGERS LOCATE A STABLE ALTERNATIVE LIVING ARRANGEMENT FOR THE CLIENT. DURING THE CLIENT'S TIME AT LOST-N-FOUND EMERGENCY HOUSE, YOUTH HAVE 3 SQUARE MEALS PER DAY, CLOTHING, AND THE RANGE OF SERVICES PROVIDED THROUGH THE LNFY YOUTH CENTER. THE COVID

YOUTH HOUSE: THE YOUTH HOUSE IS A 6-BED FACILITY LOCATED IN ATLANTA'S HISTORIC WEST END WHICH HOUSES YOUTH FOR UP TO 6 MONTHS WHILE THEY BUILD THEIR INDIVIDUAL CAPACITY FOR INDEPENDENCE, SELF-SUFFICIENCY AND PERMANENT HOUSING. WHILE ENROLLED IN THE YOUTH HOUSE YOUTH ARE REQUIRED TO SECURE AND MAINTAIN FULL TIME EMPLOYMENT, SAVE 60% OF THEIR
